- Is a public health program for the early detection of disorders that can lead to mental retardation and death. All infants born in accredited facilities shall be tested for Expanded Newborn Screening. ENBS increase the number of disorders in the panel from six (6) to more than 28. This services is available in 5 public lying in and done ideally immediately after 24 hours from birth.
