### RESOLUTION TO AWARD

**WHEREAS**, on 19 January 2023, the Bids and Awards Committee ("BAC") received from the **Pasig City General Hospital (PCGH)** ("END-USER") the Purchase Request No. **100-23-01-058** "SUBJECT P.R.") for the **Supply and Delivery of 200 Pads Certificate of Death and 500 Pads Certificate of Live Birth** ("PROCUREMENT PROJECT") with an Approved Budget for the Contract ("ABC") of **One Hundred Sixty Eight Thousand Pesos (Php 168,000.00)**;

**WHEREAS**, on 10 February 2023, the BAC sent out a Request for Quotation ("RFQ") to the three (3) Recognized Government Printers (RGP) through electronic mail;

**WHEREAS**, in response to the RFQ, **National Printing Office** timely submitted its quotation with the following amount;

**WHEREAS**, following Appendix 20 of the Implementing Rules and Regulations of Republic Act No. 9184 or the Guidelines on the Procurement of Printing Services, the BAC evaluated all the quotations received and determined that **NATIONAL PRINTING OFFICE** is the most capable in performing the printing service in the SUBJECT P.R. in the most advantageous terms for the City Government of Pasig;

**WHEREFORE, BE IT RESOLVED**, that the BAC, after deliberation and upon careful examination of the offer submitted by the **NATIONAL PRINTING OFFICE**, recommends to the Head of the Procuring Entity the award of the contract for the PROCUREMENT PROJECT as proposed and submitted by the END-USER through the SUBJECT P.R. for a total amount of **One Hundred Sixty Eight Thousand Pesos (Php 168,000.00)**.
