Pursuant to the Resolution to Award dated MAY 17 2023 issued by the Bids and Awards Committee, we are pleased to inform you that your bid for the **REPAIR AND IMPROVEMENT OF SCHOOL BUILDING FACILITIES AT PASIG CITY SCIENCE HIGH SCHOOL, BRGY. MAYBUNGA, PASIG CITY** under ITB No. PB-03-13-2023-03, in the amount of **TWO MILLION FOUR HUNDRED SEVENTY THOUSAND FOUR HUNDRED NINETY-SEVEN THOUSAND AND 56/100 ONLY (PHP 2,470,497.56)** has been awarded to you.

In this regard, you are therefore required, within ten (10) calendar days from receipt of this Notice to Award:

1. Submit to the Procurement Management Office (PMO) a performance security pursuant to Section 39 of the revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184;
2. In accordance with Section 37.2 of the IRR of RA No. 9184, submit to the PMO the following documents:
 - a. Two (2) sets of the blue prints of the approved plans for the project,
 - b. Proof of posting of the tarpaulin signboard in compliance with Commission on Audit Circular No. 2013-004,
 - c. Photocopy of any government-issued ID and Community Tax Certificate (CEDULA) of your authorized signatory,
 - d. Professional Regulation Commission (PRC) ID and Community Tax Certificate (CEDULA) of your resident engineer,
 - e. Certification that the contractor undertakes to employ at least eighty percent (80%) of its manpower from bonafide residents of Pasig City, and
 - f. Certification of list of equipment requirements owned/leased by the contractor that will be used for the project.
3. Sign the contract as provided in Section 37.2 of the IRR of R.A. 9184.


