



**RESOLUTION TO AWARD ITEM 1 AND 14 UNDER ITB NO. BAC-22-0726B**

**WHEREAS**, on 27 July 2022, the City Government of Pasig through the Bids and Awards Committee ("BAC") posted in the Philippine Government Electronic Procurement System ("PhilGEPS"), at a conspicuous place reserved for this purpose in the premises of the procuring entity, and the City Government website, an advertisement for the procurement of **SUPPLY AND DELIVERY OF VARIOUS MEDICAL SUPPLIES AND EQUIPMENT – PCCH** with an Approved Budget for the Contract of Forty Million Three Hundred Twenty-Two Thousand Three Hundred Ninety-One Pesos (PHP40,322,391.00) under ITB No. bac-22-0726b;
