Pursuant to the Resolution to Award dated MAY 19 2023 issued by the Bids and Awards Committee, we are pleased to inform you that your bid for the **REPAIR AND IMPROVEMENT OF VARIOUS SCHOOL BUILDINGS AND FACILITIES AT ILUGIN ELEMENTARY SCHOOL, BRGY. 1. Submit to the Procurement Management Office (PMO) a performance security pursuant to Section 39 of the revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184;
2. In accordance with Section 37.2 of the IRR of RA No. 9184, submit to the PMO the following documents:
  - a. Two (2) sets of the blue prints of the approved plans for the project,
  - b. Proof of posting of the tarpaulin signboard in compliance with Commission on Audit Circular No. 2013-004,
  - c. Photocopy of any government-issued ID and Community Tax Certificate (CEDULA) of your authorized signatory,
  - d. Professional Regulation Commission (PRC) ID and Community Tax Certificate (CEDULA) of your resident engineer,
  - e. Certification that the contractor undertakes to employ at least eighty percent (80%) of its manpower from bonafide residents of Pasig City, and
  - f. Certification of list of equipment requirements owned/leased by the contractor that will be used for the project.
3. Sign the contract as provided in Section 37.2 of the IRR of R.A. 9184.


