Pursuant to the Resolution to Award dated 15 April 2024 issued by the Bids and Awards Committee, we are pleased to inform you that based on your bid for the **PROCUREMENT OF VARIOUS FOOD SUPPLIES – PCGH (FRAMEWORK AGREEMENT)** under **ITB No. BAC-24-0308G**, a Framework Agreement in the amount of One Peso (PHP1.00) as consideration for the option to procure the goods and services in the Framework Agreement List when the need arises in the amount of **SEVENTEEN MILLION FOUR HUNDRED THIRTY-FIVE THOUSAND SIX HUNDRED THIRTY-TWO PESOS (Php17,435,632.00), has been awarded to you.**

- Submit to the Procurement Management Office a performance security pursuant to Section 39 of the revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184 valid until the issuance by the End-user Unit of a Certificate of Completion/Final Acceptance; and
- 2. Sign Framework Agreement No. <u>FA-03-27-24-0193</u> as provided in Appendix 32 of the IRR of R.A. 9184.

Pursuant to Section 39 and 40 of the IRR of R.A. 9184, failure to sign and enter into the contract and post the foregoing performance security within the period stipulated shall constitute sufficient ground for cancellation of the award.

The delivery of goods may commence from the date of receipt of the first Call-Off for this project. The date of completion of the Framework Agreement shall be reckoned from the delivery of the last call-off. The Framework Agreement shall automatically terminate when the total maximum quantity specified in the Framework Agreement has been exhausted, or when the specified duration of the Framework Agreement has expired.

Upon receipt of this Notice, you are responsible for delivering the goods under the terms and conditions of the attached Framework Agreement. The procuring entity may execute as many Call-Offs for the same line item as may be needed within the validity of the Framework Agreement; provided that subsequent Call-Offs shall not exceed the maximum quantity in the Framework Agreement List. No other costs are authorized unless otherwise specified in the Framework Agreement.
