## CONTRACT AGREEMENT

This CONTRACT AGREEMENT is entered into and executed by and between:

- (1) THE CITY GOVERNMENT OF PASIG, a local government unit existing under Philippine laws, with postal address at Pasig City Hall, Caruncho Avenue, Brgy. San Nicolas, Pasig City, Metro Manila, herein represented in this Act by its City Mayor, Hon. Victor Ma Regis N. Sotto (the "Procuring Entity"); and
- (2) A.C. ONG CONSULTING INC., a company duly organized in accordance with and registered under the laws of the Philippines, and with business address at Lot 10, Blk 4, Dona Carmen St., Balibago, Angeles City, represented in this Act by ALDEN C. ONG (hereinafter referred to as the "Supplier").

WHEREAS, the Procuring Entity invited Bids for the procurement of MAPPING AND SURVEY SERVICES FOR THE RELOCATION SURVEY OF 19 LOTS FOR THE PROPOSED HOUSING PROJECTS IN PASIG CITY under REQUEST FOR QUOTATION NO. 100-24-01-179 (the "Project") and has accepted the Bid of the Supplier in the sum of SIX HUNDRED THIRTY THOUSAND PESOS (PHP 630,000.00) (hereinafter called "Contract Price").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part/s of this Agreement, *viz.*:
  - Request for Quotation, including the Terms of Reference ("TOR") (ANNEX "A");
  - ii. Winning bidder's bid (ANNEX "B");
  - iii. Notice of Award of Contract, and the Bidder's conforme thereto (ANNEX "C");
  - iv. Other contract documents that may be required by existing laws and/or the Procuring Entity. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, shall likewise form part of the Contract.
- 2. Supplier shall complete the project in accordance with the Delivery Term specified in the TOR.
- In consideration for the sum of SIX HUNDRED THIRTY THOUSAND PESOS (PHP 630,000.00), the Supplier agrees to deliver the goods and/or perform the services of the contract in accordance with its Bid.
- 4. The Procuring Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
- 5. When the supplier fails to satisfactorily deliver goods under the contract within the specified delivery schedule, inclusive of duly granted time extensions, if any, the supplier shall be liable for damages for the delay and shall pay the procuring entity liquidated damages, not by way of penalty, an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed goods scheduled for delivery for every day of delay until such goods are finally delivered and accepted by the procuring entity concerned.

- The Supplier grants the Procuring Entity all rights, title, and interest in and to any and all work product created for and in the course of this project, including all intellectual property rights therein and thereto.
- The Supplier agrees that all information disclosed by the Procuring Entity during the procurement process and the implementation of this Agreement shall remain the sole and exclusive property of the Procuring Entity.
- In the exercise of their rights and compliance with the obligations under this Agreement, the Parties shall observe and comply with Republic Act No. 10173, otherwise known as the "Data Privacy Act of 2012", its implementing rules and regulations, as well as all issuances of the National Privacy Commission.
