Invitation to Bid for Repair and Repainting Works at Various School Buildings at Sagad Elementary School and Sagad High School, Brgy. Sagad, Pasig City.

The City Government of Pasig, through the Special Education Fund (SEF) Annual Budget, as approved by the Pasig City Local School Board Resolution No. 7 Series of 2022 dated 27 December 2022 to apply the sum of PHP 9,814,353.27 being the Approved Budget for the Contract (ABC) to payments under the contract Repair and Repainting Works at Various School Buildings at Sagad Elementary School and Sagad High School, Brgy. Sagad, Pasig City. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
- 2. The City Government of Pasig now invites bids for the above Procurement Project. Completion of the Works is required 150 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

A complete set of Bidding Documents may be acquired by interested bidders on February 24, 2023 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PHP 10,000.00.The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.
- 6. The City Government of Pasig will hold a Pre-Bid Conference on March 3, 2023, 1:30 P.M., at 7th Floor Meeting Room, Pasig City Hall which shall be open to prospective bidders.
