

TERMS OF REFERENCE FOR PEDIATRIC TEXTBOOKS

- 1. The textbooks must comply with the department's required textbook edition as indicated and requested from the list of books, and in compliance with the requirement of the Philippine Pediatric Society (refer to list of books).
- 2. The textbooks should be in original versions and especially not photocopies.
- 3. The textbooks should be hardbound.
- 4. The textbooks should be new and in perfect condition with no torn / missing pages, free from errors in printing and without damage of covers.
- 5. Accompanying materials (if applicable) like online access, CDs should be included/enclosed with the textbook.
- 6. Warranty: Textbooks found with defects must be replaced with a new copy within sixty (60) days from the date of notice given by the end user.
- 7. Delivery Period: Within thirty (30) calendar days upon the supplier's receipt of the signed purchase order.
- 8. Terms of Payment: 45 days after delivery of the books
