**TERMS OF REFERENCE FOR REPAIR AND PREVENTIVE MAINTENANCE OF
VARIOUS MEDICAL EQUIPMENT 2023**
Pasig City Children's Hospital – Molecular Laboratory

The winning bidder/service provider shall:

1. Conduct Preventive Maintenance according to the protocol of Pasig City Children's Hospital – Molecular Laboratory Department.
2. Preventive Maintenance includes, but is not limited to: (1) general functional check-up of all the parts of the equipment (2) calibration, (3) repair, (4) cleaning, and (5) recommendation to replace parts.
3. Provide Technical Service Report, Certificate of Calibration, and/ or Certificate of Preventive Maintenance duly signed by a license equipment engineer upon rendering of service.
4. Provide Pasig City Children's Hospital – Molecular Laboratory Department, the list of tools and instruments that will be used for calibrating the equipment and certification that the equipment is maintained and calibrated in accordance with International Safety Standards.
5. Respond to emergency calls for repair of equipment via phone call, SMS, remote resolution, or onsite from the date of signing the contract/ purchase order until the end of the current year. For corrective maintenance service, in cases of emergency, the winning bidder/service provider should respond within twenty-four (24) hours upon notice.
6. Abide by and cause its personnel to comply with any laws, rules, and regulations applicable to its operations as well as with all existing policies, guidelines, and hospitals regulations issued by Pasig City Children's Hospital – Molecular Laboratory Department or any of its Hospital Department including office orders issued in relations to the service under this contract.
7. Administer emergency treatment and diagnostics in the event the winning bidder/service provider's personnel is injured in the course of duty. If after investigation by PCCH, it was found that the proximate cause of the injury was:
 - a. The fault, negligence or non-compliance to any rules, regulation or protocol by the service provider's personnel. The winning bidder/service provider shall pay for the emergency treatment, diagnostics rendered and other hospital bills incurred by its personnel.
8. Terms of Delivery Service: Must conduct Preventive Maintenance/ Calibration within 30 days upon the date of signing the contract/ purchase order.
9. For every service rendered, the winning bidder/service provider shall charge Pasig City the service price consistent with the approved and agreed pricing during the bidding.
