The CHD-Physical Therapy Section seeks to engage the services of an authorized supplier/contractor for the procurement of four (4) hand dynamometer with the following specifications:

HAND DYNAMOMETER

Description

Measures isometric grip force and strength increases in rehabilitation and physical therapy programs. It is ideal for routine screening of grip strength and initial and ongoing evaluation of hand trauma and dysfunction.

General Specifications:

- Measures from 00-200 lbs of 90kgs
- Accommodates small and large hand sizes, with five grip positions from 1.375" to 3.375"
- Dual scale readout that measures isometric grip force in both pounds and kilograms
- · Peak hold needle retains highest reading until reset
- Scratch-resistant UV coating that protects all digital components from damage
- Unit must not have internal moving parts
- Must have calibration certificate

Accessories

- Carrying case
- Complete manuals with use and complete instructions for hand strength and flexibility screening

Other Terms and Conditions
