Invitation to Bid for Renovation (with Office Extension) at Pasig Business One Stop Shop (B.O.S.S.) Meralco Avenue, Brgy. Ugong, Pasig City.

The City Government of Pasig, through the Annual or Supplemental Budget, as approved by the Sanggunian intends to apply the sum of PHP 8.132.961.84 being the Approved Budget for the Contract (ABC) to payments under the contract Renovation (with Office Extension) at Pasig Business One Stop Shop (B.O.S.S.) Meralco Avenue, Brgy. Uqonq, Pasig City. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
- 2. The City Government of Pasig now invites bids for the above Procurement Project. Completion of the Works is required 90 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

A complete set of Bidding Documents may be acquired by interested bidders on May 3, 2023 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PHP 10,000.00.The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.
- 6. The City Government of Pasig will hold a Pre-Bid Conference on May 10, 2023, 10:00 A.M., at 7th Floor Meeting Room, Pasig City Hall which shall be open to prospective bidders.
- 7. Bids must be duly received by the Procurement Management Office (BAC Secretariat Office) through manual

submission at the office address as indicated below, on or before 9:30 A.M. of May 22, 2023. Late bids shall not be accepted.

- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9. Bid opening shall be on May 22, 2023 at 10:00 A.M. at the given address below 7th Floor Meeting Room, Pasig City Hall. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The address for submission of bids is at the Procurement Management Office (BAC Secretariat Office), 4th Floor Pasig City Hall Caruncho Avenue, San Nicolas Pasig City. The deadline for submission of bids is on or before 9:30 A.M. of May 22, 2023.
