5	<p><b>ADDENDUM TO TERMS OF REFERENCE</b></p> <p>Considering that two pairs of socks will be provided to each beneficiary, each pair will be held together by a small aluminum clip and the two pairs will be consequently bundled using a small strip of paper/cardboard whose ends are joined together.</p> <p>Moreover, to prevent damage to the item and for easier distribution, every 100 pairs of socks will be packed in 1 clear, transparent plastic.</p>
6	<p><b>CLARIFICATION</b></p> <p>During the process of taking the measurements per school, the winning bidder will have to provide enough samples for each size so the students can personally choose the most suitable size for them. After which, the supplier can note the actual count per size to be supplied.</p>
