SERVICE REQUIREMENTS:

- The supplier/contractor shall supply, deliver, and install all air conditioning units designed to satisfy the technical requirements.
- 2. The supplier/contractor shall supply, deliver, and install the air conditioning units which shall be completed within **sixty (60) calendar days**.
- 3. The supplier must turn over the installation and /owner's manual that is included in the units.
- 4. The supplier must send within **twenty-four (24) hours** the necessary personnel/technician to attend, investigate and fix/trouble shoot any abnormal operation or breakdown of the unit.
- 5. The supplier must submit warranty certificate with inclusive date upon delivery. All equipment's, parts and components found defective during and within the warranty period shall be immediately replaced without additional cost.

SCOPE OF THE PROJECT

- 1. The supplier shall furnish labor, supervision, equipment and materials for the following works:
 - a.) Supply, delivery, installation and commissioning of six (6) brand new inverter wall mounted split type air-con units.
 - b.) Brand new and appropriate refrigerant pipes, fitting clamps, brackets and other mechanical accessories.
- All air-con equipment shall be installed in the location what will be designated by the Facilities
 Management Section of Pasig City Children's Hospital.
- 3. The supplier shall flush the system (new refrigerant pipes and fittings) with Nitrogen: ensure that refrigerant oil is sufficient.
- 4. The supplier shall leak test PVC pipe drainage.
- 5. The supplier shall close / restore all openings to its original condition during the installation and commissioning of the air conditioning units.
- 6. The supplier shall thoroughly clean the project site including area disturbed by installation of the air conditioning units for the duration of the project.
- 7. The supplier shall provide tools and equipment which are capable of producing the quality and quantity of work and materials required to complete the project.
