Scope of Work

a. Processing of permit to transport and issuance of Certificate

for disposal and treatment.

b. Collection, hauling and disposal services of hazardous and special wastes generated by the Pasig City Cemetery. (old clothes, shoes and other residual waste inside the niche to

All kinds of coffin).

Project Description:

This project envisioned to further improve and enhance the management and disposal of hazardous and special waste

generated by the Cemetery.

Capability:

The bidder must possess the operational capabilities as stated hereunder. Appropriate documents must be submitted as proof thereof.

a. Accreditation/registration with the DENR-EMB and DOH as Hazardous/Special waste transporter.

b. Accreditation of collection vehicles (closed 6-wheeler dumptruck) must possess at least three (3) collection vehicles as assurance for uninterrupted services.

c. Pollution Control Officer for personnel involved in field operation.

d. Must have an existing agreement with DENR-EMB and DOH as treater of hazardous/special wastes

Other requirements:

- a. Provision of special wastes bin for generated wastes to be used temporary storage while waiting collection.
- b. Must provide and apply sanitizing and solutions/chemicals every scheduled collection.
- c. All key personnel must be provided with identification and uniforms and personal protective equipment (PPE).
- d. Vehicles must always be road worthy and must have an updated OR/CR of all vehicles.

Specification of Services to be procured:

The Bidder shall provide all the chemicals, materials, equipment (hauling vehicle) and tools necessary to properly perform the task specified in the contract to wit;

Description Hazardous and Special Waste

Unit price * P 55.00/kg.

Other Terms and Condition:

The duration of the contract to be bid will be for three months until December, 2023 for this year through the approved budget subject for evaluation prior continuation of the next succeeding years of operation. The collection will be twice a month – every 15th and 30th day of the month or as the need arises.

Payment shall be based on the actual volume/weight collected per trip with a maximum of 750 kgs per truck. Additional trips maybe undertaken upon the written request of Pasig City Cemetery and/or authorized Pasig City Official representative.

The monthly billing statement shall be submitted to the City Civil Registry Office on the first working day of the month following the monthly with all complete supporting documents attached.

All payment shall be subject to the applicable taxes and existing accounting and auditing rules and regulations applicable to the Pasig City Government.
