SAMSUNG ULTRASOUND MACHINE WITH MODEL: UGEO HM70A,

The Service Provider shall:

1. Respond and act on emergency call for any repair of equipment once called via phone call, SMS or onsite.
2. Ensure that the replaced parts should be compatible with the existing Samsung Ultrasound Machine owned by the PCGH.
