

### Subscription to Adobe Creative Cloud Suite License

#### I. OBJECTIVES

To implement the Pasig City Branding and ensure its use in the City's collaterals, the Public Information Office must be equipped with the proper tool; thus, in 2022, it procured the subscription to (1) Adobe Creative Cloud Suite License.

The project aims to:

- continue the usage of Adobe cloud-based application software through renewal of the existing license of Adobe Creative Cloud of the Public Information Office;
- acquire new license of Adobe Creative Cloud
- install and activate Adobe Creative Cloud on four computers.

#### II. DURATION OF THE CONTRACT

The contract for the subscription for adobe cloud-based application software shall be twelve (12) months from the issuance of the Notice to Proceed.


