Processing of payment upon completion of delivery with acceptance and inspection report.


**F. REQUIREMENTS / SPECIFICATIONS**

1. Insulin Syringe should be manufactured by a leading brand, with permanently attached needle, G29 X ½, U-100, Sterile, Disposable, with Certificate of Medical Device Registration CPR & CGMP required to be submitted upon issuance of the Notice of Award.
2. Disposable Syringe with Needle G-23 X 1, 3cc/ml, Sterile, Luer Lock tip with Certificate of Medical Device Registration CPR & CGMP required, to be submitted upon issuance of the Notice of Award.
3. Sterile Gauze Pad, individually wrapped, 4x4 (12ply) x100, 100% Cotton Materials.
4. All deliveries must conform to the specifications stated in the Purchase Request and Terms of Reference (TOR). Any changes must be mutually agreed by both parties and must be beneficial to the end user.
