

**TERMS OF REFERENCE OF 40 PIECES OF BATTERIES TO BE USED FOR THE UNINTERRUPTIBLE POWER SUPPLY (UPS) IN THE PASIG CITY GENERAL HOSPITAL'S MAGNETIC RESONANCE IMAGING MACHINE (MRI).**

1. The supplier shall be responsible for the notification, transportation delivery, and commissioning at no cost to the government.
2. Bid offer in Philippine Peso shall include taxes and duties, transportation to site delivery, installation, and testing expenses on site (hospital) by the bidder.
3. Two (2) years warranty for the 40 pieces of UPS batteries and two (3) years services after acceptance and testing of the UPS system.
4. The supplier must certify that the 40 batteries are compatible with the current UPS system.
5. That the 40 pieces batteries of the UPS system are brand new, unused, and not a discontinued model or was listed in the market recall.
6. The supplier must provide a valid ISO # 9001 certificate of the manufacturer.
7. The machine should conform to the IEC standard or its equivalent national standard. The supplier must provide a Certificate of Declaration of Conformity.
8. Guarantee delivery of 40 batteries within 45 calendar days upon receipt of Notice to Proceed (NTP).
9. That the terms and conditions stated in the contract shall be honored by the manufacturer in the event that a change of exclusive distributorship will occur during the duration of the said contract.
