TERMS OF REFERENCE

A. PROCUREMENT TITLE

Procurement of a Learning Service Provider for the Conduct of Seven (7) Days Training of Emergency Medical Responder Training with EMS-NC II for Pasig City DRRMO personnel

B. BACKGROUND

Due to various incidents happened in different areas in Pasig City including Natural catastrophes happened in different parts of the Country and the World, PCDRRMO-Training Division sees that there is an urgency to provide our personnel a training method for EMS with worldwide standards especially for our Pasig Emergency Unit (PEU) and Pasig City Fire and Rescue personnel. This Emergency Medical Responder (EMR-EMS NC II) is a dynamic training course featuring lecture, video, simulated emergency situations, discussion and hands-on skill practices.

C. OBJECTIVES

At the end of the training, the participants will be able to:

- 1. Develop a better understanding on Emergency Medical Responder standard process;
- 2. Perform the right procedure and assessment to patient with the highest level of First Aid and CPR/AED Training;
- 3. Acquire knowledge and skills necessary in an emergency to help sustain life, reduce pain and minimize the consequences of injury
