**Equipment Name:** Blood Coagulation Machine **Model:** Sysmex CA-600

- 1. Provision of Certificate of Product Registration/Certificate of Exemption.
- 2. Minimum of two (2) years date of expiry, must be indicated in each item and packaging.
  - Must provide guarantee letter/assurance upon delivery of items if expiration is less than two (2) years
- 3. Delivery of approved Purchase Order
