TERMS OF REFERENCE SECONDARY CONNECTIVITY PROJECT

The City Government of Pasig, through the efforts of the Management Information Systems Office (MISO) intends to subscribe for a secondary centralized internet connectivity as a preparatory move towards disaster preparedness, avoid the absolute dependence on the centralized primary connectivity and make sure online systems and operations dependent on internet connection remain functional regardless of any untoward situation happened on the primary connectivity because of redundancy brought by this project.

BACKGROUND

As we navigate through these challenging times and adapt to the evolving circumstances, our LGU has shown resilience in conducting business. We have implemented digitized methods for submitting requirements, utilizing free/open-source applications, and re-engineering processes to better serve our customers. Through collaborative efforts across various departments, we have successfully adjusted our operations to ensure the continued generation of revenue for the city.

To enhance and maintain our commitment to excellent customer service, it is essential to complement our ongoing initiatives with a robust IT Digitalization plan. The objective is to provide both PCG and our customers with a seamless and meaningful experience by implementing an updated IT infrastructure that promotes efficiency in conducting business.

While we already have centralized internet connectivity, it is crucial not to solely rely on a single internet provider. We must ensure that all systems remain operational, even if our primary Internet provider encounters challenges that may affect their service delivery. Therefore, it is imperative to establish a secondary connectivity, creating redundancy that guarantees an alternative connection in the event of outages, whether they occur unexpectedly or as part of planned maintenance.
