RENEWAL OF GOOGLE TEACHING AND LEARNING UPGRADE FOR THE LEARNING MANAGEMENT SYSTEM OF THE PAMANTASAN NG LUNGSOD NG PASIG

Software Requirements

The Pamantasan ng Lungsod ng Pasig (PLP) will renew its subscription to the existing Google Workspace for Education Cloud-Based Learning Management System. It will include the additional features of the system to standardize its platform for delivering online courses. The platform will be needed for the delivery of flexible learning this coming First Semester Academic Year 2023 - 2024.

Below are the minimum requirements for the renewal of the Google Workspace Teaching and Learning Upgrade.

- 1. Access to Google Workspace for Education Teaching and Learning Upgrades Learning Management System (LMS) with maintenance, technical, and user support services.
- 2. Renewal and activation of the Google Workspace Learning Management System for Pamantasan ng Lungsod ng Pasig.
- 3. The LMS shall be seamlessly accessible through all platforms via web and mobile
 - a. Accessible via Windows, IOS, Linux, and operating systems.
 - b. Availability of mobile application access via Android and IOS devices.
- 4. The LMS shall possess features of a Cloud-based Learning Management System to which exams and learning activities may be configured towards a path or sequence according to preconfigured flow/structure as designed by the course teacher.
 - a. Items for initial configuration shall include but not be limited to:
