

**TERMS OF REFERENCE**

**Procurement for the Supply and Delivery of Carpentry and Plumbing Supplies**

- I. **PROJECT NAME: CARPENTRY AND PLUMBING SUPPLIES – PAMANTASAN NG LUNGSOD NG PASIG**
- II. **OBJECTIVE**
  1. To facilitate carpentry and plumbing repairs more efficiently.
  2. To have supplies for the use of carpenter and plumber in maintaining the smooth operation of offices and the building as a whole.
- III. **RESPONSIBILITIES OF THE SUPPLIER**
  1. The winning Bidder should strictly adhere to RA 7394 (Consumer Act of the Philippines of 1991) as this protects the end user.
  2. The date of manufacture of the items should be written on the items or their packaging. Items with a manufacturing date older than twelve (12) months on the date of delivery will be rejected and Bidder shall be liable to replace the same with new ones.
  3. Only genuine products will be accepted. Any "counterfeit products" will not be accepted.
  4. The Bidder must issue a Certificate of Warranty at least good for one (1) year.
