Invitation to Bid

Invitation to Bid for Asphalt Overlay Work at Sgt. Santos St., Brgy. Bagong Ilog, Pasig City (REBID).

1. The City Government of Pasig, through the Annual or Supplemental Budget, as approved by the Sanggunian intends to apply the sum of PHP 1,141,598.94 being the Approved Budget for the Contract (ABC) to payments under the contract Asphalt Overlay Work at Sgt. Santos St., Brgy. Bagong Ilog, Pasig City (REBID). Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The City Government of Pasig now invites bids for the above Procurement Project. Completion of the Works is required 30 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Interested bidders may obtain further information from City Government of Pasig and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M. office hours.

5. A complete set of Bidding Documents may be acquired by interested bidders on January 31, 2024 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PHP5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.

6. The City Government of Pasig will hold a Pre-Bid Conference on February 7, 2024, 1:30 P.M., at 7th Floor Meeting Room, Pasig City Hall which shall be open to prospective bidders.
