6. Warranty: Textbooks found with defects must be replaced with a new copy within sixty(60) days from the date of notice given by the end user.
7. Delivery Period: Within sixty (30) calendar days upon the supplier's receipt of the signed Notice to Proceed (NTP)
8. Terms of Payment: 45 days after delivery of the books
