RESOLUTION REVOKING THE CANCELLATION OF CONDUCT OF COMPETITIVE BIDDING

WHEREAS, on 05 January 2024, the City Government of Pasig through the Bids and Awards Committee ("BAC") posted an Invitation to Bid for the **PROPOSED EXPANSION WITH IMPROVEMENT WORKS AT PASIG CITY CHILDREN'S HOSPITAL, INDUSTRIA CORNER ALCALDE JOSE STS., BRGY. KAPASIGAN, PASIG CITY** ("Procurement Project") with an Approved Budget for the Contract of **THREE HUNDRED NINETEEN MILLION SEVEN HUNDRED SEVENTY-EIGHT THOUSAND THREE HUNDRED SEVENTY-FOUR PESOS AND 90/100 (PHP 319,778,374.90)** under **ITB-PB-01-24-2024-02**;

WHEREAS, on 12 January 2024, the pre-bid conference was conducted to discuss the conduct of public bidding and the contents of the Bidding Documents, wherein five (5) prospective bidders attended;

WHEREAS, four (4) bidders submitted their eligibility requirements, technical and financial proposals, to wit:

WHEREAS, the bid proposal of **JOINT VENTURE BETWEEN HABAKKUK CORP. AND R.R. ENCABO CONST. INC.** was not accepted by the BAC pursuant to Clause 7 of the Invitation to Bid of the Bidding Documents that states:

"Late bids shall not be accepted."

WHEREAS, on 24 January 2024, before the opening of the submitted bids, the BAC noticed that the completion days of the Procurement Project is 600 calendar days where a Multi-Year Contracting Authority ("MYCA") Resolution or its equivalent document as approved by the Sangguniang Panlungsod is required;

WHEREAS, the BAC took custody of the submitted bids for the referenced project and postponed its bid opening while compliance to the aforementioned requirement is being verified;


WHEREAS, on 24 January 2024, the BAC issued **RESOLUTION DECLARING THE CANCELLATION OF CONDUCT OF COMPETITIVE BIDDING** pursuant to Section 4.1 of Ordinance No. 75 S.2023, which was approved by the Head of the Procuring Entity;

WHEREAS, upon further study of the requirements, it shows that the reference project is a Multi-Year Project ("MYP") with appropriations available in full during the first year of implementation and hence, does not require MYCA;

WHEREAS, considering the foregoing, the BAC recommends to:

1. Revoke the **RESOLUTION DECLARING THE CANCELLATION OF CONDUCT OF COMPETITIVE BIDDING** for the **PROPOSED EXPANSION WITH IMPROVEMENT WORKS AT PASIG CITY CHILDREN'S HOSPITAL, INDUSTRIA CORNER ALCALDE JOSE STS., BRGY. KAPASIGAN, PASIG CITY** under **ITB-PB-01-24-2024-02**;
2. Proceed with the conduct of the procurement activity for the aforementioned project until completion; and
3. Notify the bidders for the referenced project of the bid opening set on 26 February 2024 10:00 AM at the Meeting Room, 7th Floor, Pasig City Hall.
