Invitation to Bid

Invitation to Bid for Concreting / Upgrading of Roads and Construction of CHB Lined Canal at Interior Roads, Caliwag St., Unity, Brgy. Pinagbuhatan, Pasig City.

- 1. The City Government of Pasig, through the Annual or Supplemental Budget, as approved by the Sanggunian intends to apply the sum of PHP 2,613,060.46 being the Approved Budget for the Contract (ABC) to payments under the contract for Concreting / Upgrading of Roads and Construction of CHB Lined Canal at Interior Roads, Caliwag St., Unity, Brgy. Pinagbuhatan, Pasig City. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
- 2. The City Government of Pasig now invites bids for the above Procurement Project. Completion of the Works is required 90 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from City Government of Pasig and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M. office hours.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on March 8, 2024 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PHP5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.

- 6. The City Government of Pasig will hold a Pre-Bid Conference on March 15, 2024, 1:30 P.M., at 7th Floor Meeting Room, Pasig City Hall which shall be open to prospective bidders.
- 7. Bids must be duly received by the Procurement Management Office (BAC Secretariat Office) through manual submission at the office address as indicated below, on or before 9:30 A.M. of March 27, 2024. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9. Bid opening shall be on March 27, 2024 at 10:00 A.M. at the given address below 7th Floor Meeting Room, Pasig City Hall. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The address for submission of bids is at the Procurement Management Office (BAC Secretariat Office), 4th Floor Pasig City Hall Caruncho Avenue, San Nicolas Pasig City. The deadline for submission of bids is on or before 9:30 A.M. of March 27, 2024.
