SUPPLY, DELIVERY and INSTALLATION of PARTS for the SEWERAGE TREATMENT PLANT (STP) OF PASIG CITY CHILDREN'S HOSPITAL – CHILD'S HOPE

Project Description:

This project entitled, “**Supply, Delivery and Installation of Parts for the Sewerage Treatment Plant**”, is envisioned to maintain its good running condition.

Scope of Works:

Supply of labor, materials and technical supervision for the replacement of defective parts for the Sewerage Treatment Plant.

A. Screen Chamber

- Plugging of Leaks at Screen Chamber
- Supply and Installation of Stainless Steel Screen, Fine (assembly based on actual condition)

B. Equalization Tank
