Invitation to Bid for Rehabilitation of Drainage along Rhodora Street to Extension, Napico, Brgy. Manggahan, Pasig City (REBID).

The City Government of Pasig, through the Annual or Supplemental Budget, as approved by the Sanggunian intends to apply the sum of PHP 2,102,221.53 being the Approved Budget for the Contract (ABC) to payments under the contract for Rehabilitation of Drainage along Rhodora Street to Extension, Napico, Brgy. Manggahan, Pasig City (REBID). Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The City Government of Pasig now invites bids for the above Procurement Project. Completion of the Works is required 90 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
