The City Government of Pasig, through the Annual or Supplemental Budget approved by the Sangguniang Panlungsod intends to apply the sum of PhP 932,540,553.10 being the Approved Budget for the Contract (ABC) to payments under the contract for DESIGN AND BUILD CONTRACT FOR THE CONSTRUCTION OF TWO (2) 6-STOREY 180 UNITS AND ONE (1) 7-STOREY 120 UNITS MRB HOUSING PROJECT AT DAANG BANCA STREET, BRGY. SAN ANDRES, CAINTA, RIZAL under ITB No. PB-04-15-2024-03. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The City Government of Pasig now invites bids for the above Procurement Project. Completion of the Works is required 615 Calendar Days (C.D.). Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from City Government of Pasig and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.

until 9:30 A.M. from given address and website/s below {Insert if necessary: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP 75,000.00.The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.

- 6. The City Government of Pasig will hold a Pre-Bid Conference on 1:30 P.M. 03 APRIL 2024 at 7th Floor Meeting Room, Pasig City Hall, Caruncho Ave., San Nicolas, Pasig City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the Procurement Management Office (BAC Secretariat Office) through manual submission at the office address as indicated below on or before 9:30 A.M. 15 April 2024. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
- 9. Bid opening shall be on 10:00 A.M. 15 APRIL 2024 at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
