

TERMS OF REFERENCE

A. PROCUREMENT TITLE

Supply and Delivery of Fire Extinguishers (refill) for Offices under the City Government of Pasig

B. LOCATION

Pasig City Hall, Caruncho Ave., Brgy. San Nicolas, Pasig City

C. PROPONENT AND IMPLEMENTING AGENCY

Pasig City Government – Pasig City Disaster Risk Reduction and Management Office

D. APPROVED BUDGET OF THE CONTRACT

The ABC for the procurement under this term of reference Supply and Delivery of Fire Extinguishers (refill) for Offices under the City Government of Pasig **SIX MILLION NINE HUNDRED NINETY NINE AND EIGHT HUNDRED PESOS (Php. 6,999,800.00).**

E. PROJECT DESCRIPTION

The offices under the City Government of Pasig will employ the fire extinguishers (refill) as a first aid response to a fire. This can assist prevent disastrous damage to property and even lead to loss of life. They also have a fantastic environmental benefit because they minimize the pollution that smoke and burning debris generate.

F. DELIVERABLES

- All empty Fire Extinguishers must be pick-up by the supplier at various offices under City Government of Pasig in coordination with the end-user.
- Refilled fire extinguisher must be delivered at respective offices under City Government of Pasig in coordination with the end-user.
- All fire extinguisher must have a plastic seal, attached warranty sticker and monitoring card.
- Hydro testing of fire extinguishers to evaluate the cylinder's ability to hold pressure. It also checks for leaks, and overall strength, and is completed to ensure the safety and effectiveness of fire extinguisher.

G. QUALIFICATIONS OF PROVIDER

- The service of the equipment must within the warranty period of **1 year** and maintenance for the period of **1 year**. The equipment must be in the same good condition (eg. Conduct quarterly preventive maintenance) at its own expense including labor and cost of spare parts.
- Bidders shall have **ISO 9001** and **14001** Certification.

For HCFC 123 Fire Extinguishers, Dichlorotrifluoroethane

- -Clean Extinguishing Agent – **Approved and tested by the Bureau of Products Standard with fire rating 2A2BC and Tested 99% pure by PIPAC.**
- - No Harmful gases. It controls fire chemically, stops the combustion process itself.
- For Dry Chemical Fire Extinguishers, Mono Ammonium Phosphate
- -**approved and tested by the Bureau of Products standard with fire rating ABC and Tested 85% pure by PIPAC.**
- -ideal for ABC fire
