WHEREAS, R.A. No. 9640 amended Section 140 of R.A. 7160 on Amusement Tax, reducing the maximum tax rate thereof from 30% to 10% at the gross receipt from admission fees.

WHEREAS, in as much as this provision on amusement tax is not a self-executing provision, it is imperative that the City Government amends its provisions to reflect a new rate for amusement tax, otherwise the City Government will not be in a legal position to collect amusement tax as therein provided.

BE IT ORDAINED, by the Sangguniang Panlungsod in session assembled that:

SECTION 1. Section 42 "IMPOSITION OF TAX" of Ordinance No. 25 Series of 1992 will read as follows:

SECTION 42. IMPOSITION OF TAX – *There shall be collected from the proprietors, lessees, or operators of theaters, cinemas, concert halls, circuses, boxing stadia, and other places of amusement a rate of ten percent (10%) of the gross receipt from admission fees.*

SECTION 2. This Ordinance shall take effect after its publication in a local newspaper of general circulation.
