AN ORDINANCE AMENDING ORDINANCE NO. 40, SERIES OF 2001 PARTICULARLY ARTICLE VIII SECTION 4 OTHERWISE KNOWN AS THE TRICYCLE/PEDICAB CODE OF PASIG CITY.

BE IT ORDAINED BY THE CITY COUNCIL OF PASIG in session duly assembled that:

SECTION 1. Article VIII: Tricycle/Pedicab Franchise, Section 4 of Ordinance No. 40, series of 2001 is hereby amended to be read as follows:

"SECTION 4: FEES AND CHARGES

Motorized Tricycle (For Hire)

- a.) Registration - Php 200.00/good for 2 years
- b.) Renewal of Registration Certificate - Php 100.00/year
- c.) TORO Supervision Fee - Php 50.00/year
- d.) Special Permit - Family Service, School Service
Market Service and Delivery Service
 - d.1. All applicants of Special Permit residing in Pasig City for at least 1 year and above, shall be granted permits with the charges of Php350.00/unit/Six (6) months.
 - d.2. All applicants of Special Permit Non-Residence of Pasig City (Out of Line) shall be granted permits with the charges of Php350.00/unit/ Three (3) Months.
- e.) Transfer of Ownership - Php 100.00
- f.) Change of area zone operation - Php 100.00
- g.) Change of Unit - Php 100.00
- h.) Others that maybe fixed by the TORO, such as but not limited to license plates, tricycle stickers and other paraphernalia, duly approved by the Chief Executive."

SECTION 2. The Tricycle Operation and Regulatory Office shall promulgate such rules and regulations, with the approval of the Office of the Mayor, as are necessary, for the effective implementation of this Ordinance.

SECTION 3. This Ordinance shall take effect Fifteen (15) days after its publication in a newspaper of general circulation in Metro Manila.
