AN ORDINANCE AMENDING ORDINANCE 4, SERIES OF 2010 ENTITLED "AMENDING THE POSITIONS AND SALARY SCALE OF THE ACADEMIC STAFF AND PRINCIPAL OF THE PASIG CITY SCIENCE HIGH SCHOOL, DEFINING A SYSTEM AND TIMETABLE FOR PROMOTION AND PROVIDING FUNDS THEREFOR".

WHEREAS, Republic Act No. 6758 known as "Compensation and Position Classification Act of 1989" provides the guidelines for step increments to employees in the service based on merit and/or length of service;

WHEREAS, upon evaluation of performance of the subject academic personnel of the Pasig City Science High School, there is need to expand the lower steps of the approved plantilla as approved in Ordinance 4, Series of 2010;

NOW THEREFORE, on motion duly seconded, the Sangguniang Panlungsod ng Pasig City in session assembled, hereby amends Ordinance 4, Series of 2010 as follows:

Section 1. Section 1.6 of Ordinance 4 Series of 2010 is hereby amended to read as follows:
