One (1)	Consultant on Office Automation and Networking	P20,000.00 inclusive of allowance	Bachelor's degree relevant to the job with seven (7) years experience in office automation and networking
One (1)	Consultant on Operating System	P30,000.00 inclusive of allowance	Bachelor's degree relevant to the job with seven (7) years experience in operating system
