**WHEREAS**, there is a need to revert to savings in order to finance other priority projects, plans and programs and expenditure requirements of the City Government of Pasig for the Calendar Year 2011;

**WHEREAS**, the City Treasurer, Acting City Accountant, Acting City Budget Officer certified the existence and availability of **EIGHTY FOUR MILLION THREE HUNDRED THIRTY THREE THOUSAND TWO HUNDRED NINETY TWO PESOS & 70/100 (PhP84,333,292.70)** as available for appropriation;

**Section 1. REVERSION OF FUND** – There is hereby reverted the sum of **EIGHTY FOUR MILLION THREE HUNDRED THIRTY THREE THOUSAND TWO HUNDRED NINETY TWO PESOS & 70/100 (PhP84,333,292.70)** representing savings of the City of Pasig.
