AN ORDINANCE RENAMING BLESSED JOSEMARIA ESCRIVA DRIVE TO SAINT JOSEMARIA ESCRIVA DRIVE IN ORTIGAS CENTER, BARANGAY SAN ANTONIO, PASIG CITY.

WHEREAS, Josemaria Escriva, the founder of Opus Dei, International Catholic Institution has a Chapel located at Blessed Josemaria Escriva Drive formerly as Amber Drive, Ortigas Center, within the premises of the University of Asia and the Pacific;

WHEREAS, in 2000 the City council of Pasig has passed City Ordinance No. 44, series of 2000 renaming Amber Street in Ortigas Center into Blessed Josemaria Escriva Drive, Barangay San Antonio;

WHEREAS, on October 6, 2002, Josemaria Escriva was canonized and declared SAINT by Pope John Paul II at the St. Peter Square in Rome, Italy;

WHEREAS, the ten (10) years gap prohibition under Section 13 par (d) of R.A. 7160 have already been lapsed since City Ordinance No. 44 was enacted on November 27, 2000.

BE IT ORDAINED, by the City Council of Pasig in Session assembled that:

- Section 1. Blessed Josemaria Escriva Drive is hereby renamed as **SAINT JOSEMARIA ESCRIVA DRIVE**.
- Section 2. The former name Blessed Josemaria Escriva Drive shall be place below the name Saint Josemaria Escriva Drive on the street signs for a period of One (1) year from the date of effectivity of this Ordinance.
- Section 3. A copy of this Ordinance shall be furnished the Philippine Historical Commission, the City Library and the Engineering Office of the Pasig City Government.
- Section 4. This Ordinance shall take effect upon its approval.
