**AN ORDINANCE AMENDING THE RATES FOR SOME REGULATORY FEES  
IMPOSED BY THE CITY OF PASIG.**

**WHEREAS**, Section 186, R.A. 7160 otherwise known as the Local Government Code of 1991 provides that local government units may exercise the power to levy taxes, fees or charges on any base or subject not otherwise specifically enumerated herein of taxed under the provisions of the National Internal Revenue Code or other applicable laws;

**WHEREAS**, these regulatory fees and charges were imposed under Ordinance No. 25 in 1992 and were partially amended under Ordinance No. 43 in 2004;

**WHEREAS**, the present rates of regulatory fees and charges are already low and not commensurate to the current costs of services rendered and of the supplies and materials used.

**NOW, THEREFORE, BE IT ORDAINED THAT:**

**Section 1. NEW RATES OF FEES** – There are hereby prescribed the following new rates of regulatory fees and charges for services rendered by the City Government of Pasig.






