**AN ORDINANCE AMENDING SECTION 1 OF CITY ORDINANCE NO. 32, SERIES OF 2008 BY INCREASING THE ANNUAL FINANCIAL ASSISTANCE TO EACH BONAFIDE PASIG CITY SENIOR CITIZENS FROM ONE THOUSAND FIVE HUNDRED PESOS (P1,500.00) TO TWO THOUSAND PESOS (P2,000.00).**

**WHEREAS**, Article XV, Section 4 of the Constitution provides that the family has the duty to care for its elderly members but the State may design programs for social security;

**WHEREAS**, Section 16, Chapter II, Book I of the Local Government Code of 1991 mandates that every local government unit shall exercise the powers expressly granted, those necessarily implied as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare and Section 458 (5) (xiv) provides for the care of disabled persons, paupers, **the aged**, the sick, persons of unsound mind, abandoned minors, juvenile delinquents, drug dependents, abused children and other needy and disadvantaged persons in the community;

**WHEREAS**, the City Government of Pasig recognizes the valued contributions of senior citizens in nation-building and in nurturing the best ideals in society and family and as a token of recognitions granted annual financial assistance of One Thousand Five Hundred Pesos (P1,500.00) each to bonafide senior citizens of the city;

**WHEREAS**, the skyrocketing prices of commodities caused by the uncontrolled prices in the cost of oil resulted to financial hardships particularly to the senior citizens, and the city officials deemed it necessary to increase the financial assistance of senior citizens to cope with the spiraling cost of commodities;

**NOW, THEREFORE**, be it ordained by the City Council in session duly assembled that :

**SECTION 1.** Section 1 of Ordinance No. 32, series of 2008 is hereby amended to be read as follows:

The Office of the Senior Citizens Affairs (OSCA) together with the City of Social Welfare Office (CSWO) is hereby tasked to prepare the implementing guidelines of this Ordinance.”

**Section 2. EFFECTIVITY** - This Ordinance shall take effect immediately upon its approval.
