WHEREAS, Ordinance No. 31, s. 2008 established a Sports Scholarship Program and Training Allowance for Athletes, Coaches and Trainers in Elementary, High School and College;

WHEREAS, the Bobby C. Eusebio Scholarship Program for poor but deserving Elementary High School and College Students is established pursuant to Ordinance No. 12, s. 2007 and Ordinance No. 41, s. 2009;

WHEREAS, Ordinance No. 30 and Ordinance No. 45 both s. 2009 established the Bobby C. Eusebio Scholarship Program for out-of-school youth and athletes;

WHEREAS, the above cited ordinances were enacted by the Sangguniang Panlungsod conformably with the provisions of the Constitution which mandated that the state shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make education accessible to all. The Constitution expressly provides in Article XIV, Section 2 (3) the legal basis for the establishment and maintenance of scholarship grants, student loan programs, subsidies and other incentives which shall be available to deserving students in both public and private schools, especially to the underprivileged;

WHEREAS, the promotion of sports programs, league competitions, and amateur sports including sports training so as to foster self-discipline, teamwork, and excellence is provided in Section 19 (1) supra for the development of a healthy and alert citizenry;

WHEREAS, there is a need to augment the budget allocation of the above enumerated programs for its effective implementation.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod in session duly assembled do hereby ordained that:
