WHEREAS, the United Nations Education, Scientific and Cultural Organization (UNESCO) designated 5th of October every year as "World Teachers' Day", which is a day to celebrate the central role that teachers play in guiding the children, youth and adults throughout their school days;

WHEREAS, there is a necessity to generate awareness on the image of teaching as vocation by increasing public cognizance on the value of teachers in Philippine society and the community;

WHEREAS, the City Government of Pasig considers the meritorious services of the teachers as moulders of the youth and supports all endeavors to boost their morale and enhance the effectiveness in the performance of their duties.

NOW, THEREFORE, the Sangguniang Panlungsod in session duly assembled do hereby ordained that:

Section 1. There is hereby allocated the amount of ONE MILLION TWO HUNDRED THOUSAND PESOS (P1,200,000.00) out of any available fund of the city to defray the cost of expenses in connection with the celebration of Teachers' Month which was proclaimed by the President of the Philippines from September 5 to October 5 while the United Nations Education, Scientific and Cultural Organization (UNESCO) designated the 5th of October every year as "World Teachers' Day" and on such day to be agreed by the teachers themselves as its celebration day. *Provided*, the City Budget Officer shall include the herein amount in the regular budget of the city every year. *Provided, further*, that the amount maybe increased by the City Mayor as public service demands.

Section 2. This Ordinance shall take effect fifteen (15) days from approval.




