AN ORDINANCE CREATING THE POSITION OF UNIVERSITY VICE PRESIDENT FOR ADMINISTRATIVE MATTER IN THE PAMANTASAN NG LUNGSOD NG PASIG AND FOR OTHER PURPOSES.

WHEREAS, Section 6 (d) Ordinance No. 11, Series of 1999 created the position of University Vice President in the Pamantasan ng Lungsod ng Pasig;

WHEREAS, studies conducted in Metro Manila show that existing universities whether local or national present plantilla position for two Vice President – one for administration and the second for academics;

WHEREAS, the increase in the number of courses offered by the Pamantasan ng Lungsod ng Pasig resulted in the increase in the number of teaching and non-teaching personnels and in the concomitant increase in the student population;

WHEREAS, there is a need to synchronize and systematize the operation of the Pamantasan ng Lungsod ng Pasig for it to be more competitive and efficient in operation.

NOW, THEREFORE, be it ordained that:

Section 1. CREATION. - There is hereby created the position of University Vice President III in the Pamantasan ng Lungsod ng Pasig who shall be called Vice President for Administrative Matter.

Section 2. QUALIFICATIONS. - No person shall be appointed University Vice President III or properly called Vice President for Administrative Matter unless he is a citizen of the Philippines, a resident of Pasig City, of good moral character, holder of appropriate doctoral degree and must have experience in positions involving management and supervision for at least five (5) years.

Section 3. COMPENSATION AND OTHER BENEFITS. - The University Vice President III or properly called Vice President for Administrative Matter shall have a salary grade of 27 and shall receive the following:





Section 6. EFFECTIVITY. - This Ordinance shall take effect immediately upon approval.


