**ORDINANCE IMPOSING FEES FOR THE ISSUANCE OF CERTIFICATE OF DETENTION, CERTIFICATE OF DISCHARGE FROM THE JAIL AND ALL OTHER CERTIFICATES ISSUED BY THE PASIG CITY JAIL, BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP).**

**BE IT ORDAINED** by the Sangguniang Panlungsod of Pasig, in session duly assembled, that:

**SECTION 1.** A Certification Fee of Fifty Pesos (P50.00) is hereby imposed for the issuance of Certificate of Detention, Certificate of Discharge from the Jail or any other Certificates, including Certified True Copies of said documents, issued by the Pasig City Jail.

**SECTION 2.** The Pasig City Jail (Bureau of Jail and Penology) shall issue an Order of Payment to the applicant, who shall pay the amount required to the City Treasurer's Office prior to issuance of the requested certificate.

**SECTION 3.** Funds collected under this Ordinance shall accrue to the general fund of the city.

**SECTION 4.** Repealing Clause – If any provision of this Ordinance is declared unconstitutional or inconsistent with any existing laws, the remaining provisions shall remain valid and effective.

**SECTION 5.** Effectivity – This Ordinance shall take effect fifteen (15) days after publication in newspaper of general circulation.
