**WHEREAS**, the City Government of Pasig has cancelled obligation requests for various purchase request and infrastructure projects in the amount of **TWO HUNDRED THIRTY SEVEN MILLION SEVEN HUNDRED EIGHT THOUSAND EIGHTY ONE PESOS AND 76/100 ONLY (Php237,708,081.76)** under the General Fund;

**WHEREAS**, there is a need to revert the appropriation of **TWO HUNDRED THIRTY SEVEN MILLION SEVEN HUNDRED EIGHT THOUSAND EIGHTY ONE PESOS AND 76/100 ONLY (Php237,708,081.76)** in order to finance priority projects, programs and expenditure requirements of the City Government of Pasig for the Calendar Year 2012;

**WHEREAS**, the City Budget Officer, Acting City Treasurer and the Acting City Accountant both certified the existence and availability of **TWO HUNDRED THIRTY SEVEN MILLION SEVEN HUNDRED EIGHT THOUSAND EIGHTY ONE PESOS AND 76/100 ONLY (Php237,708,081.76)** as available source for Supplemental Budget No. 01.

**NOW, THEREFORE**, on motion duly seconded:

**Section 1.** Reversion of Fund – There is hereby reverted the sum of **TWO HUNDRED THIRTY SEVEN MILLION SEVEN HUNDRED EIGHT THOUSAND EIGHTY ONE PESOS AND 76/100 ONLY (Php237,708,081.76)** representing the savings of the City of Pasig.

**Section 2.** This Ordinance shall take effect immediately.
