**WHEREAS**, this policy is specifically enunciated in the National Government's overall pole vaulting development strategy, identifying Science and Technology as one major areas of concern and challenge to national and local development;

**WHEREAS**, it is also an avowed mandate of the City Government to pursue programs that will address the overall "human index" development of the City constituency, possibly offering scholastic, in-plant and extension Science and Technology formal schooling and industrial and extension training to enhance our expertise in this knowledge and skills sector;

**WHEREAS**, in City Ordinance No. 32 Series of 2011, the monthly allowances of students and teachers of the Pasig City Science High School were appropriated from the local school board;

**WHEREAS**, Section 82 paragraph (C) of the Manual on the New Government Accounting System for Local Government Units provides, to wit:

( c ) said proceeds (Special Education Fund or SEF) shall be allocated as determined and approved by the Local School Board concerned only for the following purposes.

1. Operation and maintenance of public schools
2. Construction and repair of school buildings, facilities and equipment
3. Educational Research
4. Purchase of Books and Periodicals; and
5. Sports Development

**WHEREAS**, the said provision does not include the allowances which barred the students and teachers of Pasig City Science High School from receiving the same, for the students starting March 2012 and for the teachers starting February 2012.


**BE IT ORDAINED BY THE CITY COUNCIL IN SESSION DULY ASSEMBLED, THAT:**

Section 1. Section 1 of City Ordinance No. 32 Series of 2011 is hereby amended to be read as follows:


*"Students of the school will received the amount of Six Hundred Pesos (P600.00) each and the teachers (getting salaries from the City Government of Pasig) will receive the amount of One Thousand Five Hundred Pesos (P1,500.00) each as monthly allowance which will be appropriated from the General Fund."*
