AN ORDINANCE AUTHORIZING THE HONORABLE CITY MAYOR TO NEGOTIATE WITH VARIOUS OWNERS FOR THE ACQUISITION OF THE PROPERTIES THAT WILL BE AFFECTED BY THE CONSTRUCTION OF SUMILANG-BUTING BRIDGE OR EXPROPRIATE THE SAME IF NEGOTIATIONS FAILED.

WHEREAS, on June 17, 2010, the Sangguniang Panlungsod passed and approved Resolution No. 60 authorizing the Honorable City Mayor to engage the services of an expert and experienced individual, association, partnership or corporation to conceptualized design, prepare specifications and program of work for the construction of a bridge and its approaches from Lopez Jaena Street, Barangay Sumilang to Barangay Buting;

WHEREAS, Section 17(a) (2) (viii), R.A. 7160 in relation to Section 17 (a) (3) of the same law, the City shall have the authority to construct infrastructure facilities intended primarily to service the needs of the residents including but not limited to roads, and bridges among others;

WHEREAS, the aforesated Sumilang-Buting Bridge is now on the construction stage and in the process, it has to pass, occupy and affect various consisting of land, buildings and improvements owned by various owners.

NOW, THEREFORE, BE IT ORDAINED for the Sangguniang Panlungsod of Pasig City in session assembled that:

Section 1. The Honorable City Mayor is hereby authorized to negotiate with various owners for the acquisition of the properties that will be affected by the construction of Sumilang-Buting Bridge.

Section 2. In case the negotiations with the various owners of the subject properties failed, the City Mayor is hereby authorized to file expropriation proceedings to acquire and compensate these properties.

Section 3. The amount to be used for the payment of just compensation shall be taken from the land capital outlay provided in the CY 2012 Budget of the City of Pasig.

Section 4. This Ordinance shall take effect immediately.






