BE IT ORDAINED by the City Council of Pasig in session duly assembled that:

Section 1. Fines and Penalties of:

- a.) **Appendix V** - Streets with limited Truck Ban will be as follows: First Offense – Five Hundred Pesos (P500.00); Second Offense – One Thousand Pesos (P1,000.00); Third Offense – Two Thousand Five Hundred Pesos (P2,500.00) and succeeding offenses within the month (P2,500.00).
- b.) **Article V Section 23** – “Driving Over a Yellow Lane / Box” One Thousand Pesos (P1,000.00) fine.
- c.) **Article XIV Section 73 (f)** “No person shall drive a tricycle along the national road and all roads within the Central Business District of the City” – One Thousand Pesos fine (P1,000.00)
- d.) **Article XVIII Section 97 (a) (e)** will be read as follows:
 - 1. Only persons with license duly issued by the Land Transportation Office (LTO) shall be allowed to drive a vehicle. Persons with Double Multiple Drivers License and those with double Multiple unredeemed OVR’s is prohibited. Fine One Thousand Pesos (P1,000.00) and impounding of vehicle.
 - 2. Section e – “driving in sleeveless shirt (sando) or slippers for public utility vehicle is prohibited. All drivers using mobile phones or similar device while driving is not allowed. Fine – driving in sandos/slippers PUV drivers only – One Hundred Fifty Pesos (P150.00); all drivers using phone or similar device while driving – fine of Five Hundred Pesos only (P500.00)
- e.) **1. Article XII Section 58 Driving a Motor Vehicle while under in the influence of liquor or incapacitating drug** – fine of Two Thousand Five Hundred (P2,500.00)Pesos and impounding of motor vehicle
- 2. Article XVIII Section 97 (a) (b) (c) (d) licenses, motor vehicles and other requirements:**

Section 2. Separability Clause – if for any reason, any section of provision of this amending ordinance is declared illegal or unconstitutional other sections or provisions hereof which are not affected thereby repealed or modified accordingly.

Section 3. Effectivity – This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation Pasig City Metro Manila.
