**AN ORDINANCE AMENDING SECTION 5 (1) OF ORDINANCE NO. 12, SERIES OF 2007 ENTITLED, "AN ORDINANCE ESTABLISHING THE BOBBY C. EUSEBIO SCHOLARSHIP PROGRAM FOR POOR BUT DESERVING ELEMENTARY, HIGH SCHOOL AND COLLEGE STUDENTS".**

**WHEREAS**, the Philippine Constitution of 1987 and Section 45, (5)(xi) of the Local Government Code of 1991, provide the establishment or maintenance of a system of scholarship grants, student loan programs, subsidies, and other incentives for deserving students, both in public and private schools especially to the underprivileged;

**WHEREAS**, the City Government of Pasig in conformity with the foretasted provisions of the law has been extending financial support to the poor but deserving Pasigueño students since 1996 by virtue of Ordinance No. 44, series of 1996 and its amendment of Ordinance 29, series of 2006;

**WHEREAS**, in Ordinance No. 12, particularly in Section 5 (1) one of the criteria for selection to avail the scholarship grant, the applicant must have a weighted average of at least 85 for the last concluded academic year, which the City Council finds it to high to achieve.

**BE IT ORDAINED**, by the City Council of Pasig in session duly assembled that:

**Section 1.** Section 5 (1) of Ordinance No. 12, series of 2007 will be read as follows:


**CRITERIA FOR SELECTION** – In order to avail of the scholarship grant an applicant must:


1. Have a weighted average grade of at least 82 for academic year.

**Section 2.** Repealing Clause: All ordinance or issuances of the City of parts thereof that are inconsistent with any of the provisions of this ordinance, are hereby repealed or modified accordingly.

**Section 3.** Effectivity: This Ordinance shall take effect upon its approval.
