BE IT ORDAINED, by the City Council of Pasig in session duly assembled that:

Section 1. Section 1 of Ordinance No. 27, series of 2011 will be read as follows:

The City Mayor is granted the authority to re-apportion the budget allocation and number of BCE Scholars in the different academic levels or classifications as warranted under the circumstances in order to make the scholarship program more responsive to the needs of the scholars, provided, however, that the total appropriated amount for the scholars allowances has not exceeded.

The budget allocation of the following programs is hereby provided as follows:

- a) Sports Scholarship Programs and Training Allowance for Athletes, Coaches and Trainers in Elementary, High School - ₱ 1,239,500.00
 - b) Bobby C. Eusebio Scholarship Program for poor but deserving Elementary, High School and College Students - ₱ 64,020,000.00
 - c) Bobby C. Eusebio Scholarship Program for Out-of-School Youth and Athletes - ₱ 2,789,500.00
 - d) Incentive Package for PLP students - ₱ 995,000.00
- TOTAL - ₱ 69,044,000.00**

Section 2. Repealing Clause: All ordinance or issuances of the City of parts thereof that are inconsistent with any of the provisions of this ordinance, are hereby repealed or modified accordingly.





Section 3. Effectivity: This Ordinance shall take effect this school year 2012-2013.




